EMSB COURSE

Prior to the European Burns Association Congress, the Dutch Burns Foundation will organize a provider EMSB course for physicians and nurses from the EU. This one day course will be held on September 13th, 2011 (one day before the start of the EBA Congress) in The Hague.

Goal: to disseminate the EMSB concept in Europe

The EMSB course has been successfully taught to medical and nursing professionals in the Netherlands for more than 10 years.

The EMSB course is implemented in Great Britain and the staff now presents the course to the other European countries and hopes this will have a catalyzing effect on disseminating the concept of the EMSB and to improve care for severely burned patients in Europe.

Disaster Committee

The task force group burn disasters in Europe was formed in 2009 at the EBA Conference in Lausanne to clarify the current European structures for cross border transfer of burn patients in disaster situations.

The following fields of activity for the EBA were identified:

1. Identify nation-specific disaster plans
2. Establish a map of risk regions
3. Explore EU grants to fund that research
4. Develop an internet-teaching platform
5. Identify normal and disaster capacity of burn centers
6. Disaster terminology
7. Harmonize victim ID Sheets
8. Optimize triage sheets for burn victims
9. Legal basis for x-border medical transport
10. Minimal standards of burn care
11. Encourage insurance x-border coverage
12. Explore transportation capacities

The initial work of the group showed that in Europe a functioning system of disaster management without a specific focus on burns has been established already. Also cross border financial coverage is working according to European legalization. National maps of risk regions are established and shared between authorities. The further task of the EBA will be to look into the specific aspects of these standards in relation to the needs of burn therapy.

Survey of infrastructure and outcome in Europe

Following the example of an investigation on structures and training in burn units of German speaking European countries (published in Burns 57 (2011) 257-64) the EBA will expand this data collection on all European Member countries of the EBA. An internet based platform and automated questionnaire will be provided in order to facilitate the data input for the members.

PAM Committee

Two years of activities

Since the last congress, the Personnel Allied to Medicine Committee (PAM) met several times. It is always a very interesting and intense moment of scientific exchanges.

We focused our discussions on Clinical guidelines regarding wound care and different psychological topics. An extensive review of literature gives plenty of information about burned children behavior and will help guidelines redaction. An overview of the psychological facilities available all over Europe is still in progress. It would inform about the different strategies in psychological care for our patients.

In cooperation with the Executive Committee, we also proposed a draft for PAM organization chapter to be included in the "European Guidelines for Burn Care Practice". Describing the role and the plus-value of each partner, this text enhances the importance of pluridisciplinary approach of burn patients.

In The Hague, during the PAM Business Meeting, we'll present the content of this work.
